Certain personnel matters when particularly named in motion. To consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official; and To consider the investigation of charges or complaints against a public employee, official, licensee, or regulated individual, unless the employee, official, licensee, or regulated individual requests a public hearing; but A public body may not hold an executive session to consider the discipline of an elected official for conduct related to the performance of the official's duties or to consider that person's removal from office. 2.) Purchase or sale of property – A public body may also adjourn into executive session to consider the sale of real or person property by competitive bid, or the sale or disposition of unneeded, obsolete, or unfit property under R.C. 505.10, if disclosure of the information would result in a competitive advantage to the person whose personal, private interest is adverse to the general public interest. No member of a public body may use this exemption a subterfuge to provide covert information to prospective buyers or sellers. Upon conclusion of this

executive session, the Board President will gavel the Board back into open session at this location. All matters discussed in this executive session are designated to the public officials and employees as confidential pursuant to R.C. 102.03(B) because of the status of the proceedings and/or the circumstances under which the information will be received, and preserving its confidentiality is necessary to the proper conduct of government business.
