WHEREAS, there were no bids that met the Board of Education's minimum bid of One Million Dollars (\$1,000,000); and

WHEREAS, the Board of Education has met its obligation to sell the Real Estate by public auction.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of the Chippewa Local School District, County of Wayne, State of Ohio that the Board has met its obligation to offer the Real Estate by public auction pursuant to Ohio Revised Code Section 3313.41.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal action of this Board concerning and/or relating to the adoption of this Resolution was taken in an open meeting of this Board and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
