WHEREAS, the Board of Education is the owner of certain real estate identified by the Wayne County Auditor as Permanent Parcel Numbers 17-01187.000, 17-01188.000, 17-01189.000, 17-01191.000, 17-01192.000, 17-01193.000, 17-01199.000 located on High Street with a second access on Pine Street, Doylestown, Ohio, and consisting of approximately 10.80 +/- acres of vacant developable land (hereafter "Real Estate"); and

WHEREAS, on June 8, 2020, the Board of Education determined by resolution that the Real Estate is not needed for or used for school purposes and the Board does not foresee the need to retain ownership of the real estate for school purposes; and authorized a sale by public auction in accordance with Ohio Revised Code Section 3313.41; and

WHEREAS, a public auction was publicly noticed and held on July 13, 2020 at 12:00 p.m.; and

WHEREAS, there were no bids that met the Board of Education's minimum bid of One Million Dollars (\$1,000,000); and

WHEREAS, the Board of Education has met its obligation to sell the Real Estate by public auction.

NOW THEREFORE, BE IT RESOLVED, by the Board of Education of the Chippewa Local School District, County of Wayne, State of Ohio that the Board has met its obligation to offer the Real Estate by public auction pursuant to Ohio Revised Code Section 3313.41.

BE IT FURTHER RESOLVED, that it is hereby found and determined that all formal action of this Board concerning and/or relating to the adoption of this Resolution was taken in an open meeting of this Board and that all deliberations of this Board and any of its committees that resulted in such formal action were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
